## 1. Welcome and apologies for absence

The Chair welcomed the participants. This meeting was organised as a teleconference to avoid traveling to EFSA in line with the measures established to reduce the risk of coronavirus infection.

## 2. Adoption of agenda

The agenda was adopted without changes.

## 3. Declarations of Interest of Working Groups members

In accordance with EFSA's Policy on Independence<sup>2</sup> and the Decision of the Executive Director on Competing Interest Management<sup>3</sup>, EFSA screened the Annual Declarations of Interest filled out by the Working Group members invited to the present meeting, please refer to Annex I. Oral Declaration(s) of Interest were asked at the beginning of the meeting and no additional interest was declared.

## 4. Agreement of the minutes of the 18<sup>th</sup> WG meeting

The minutes of the 18<sup>th</sup> WG meeting (held on 7-9 July 2020) were agreed by written procedure<sup>4</sup>.

## 5. Scientific topic(s) for discussion

There were no FCM applications for discussion. Additional information was foreseen to be received for several FCM-applications, but the applicants informed EFSA that they encountered a delay in obtaining the analytical data EFSA requested due to the Covid-situation. The deadline for submitting the additional information was therefore extended, and the applications remain in stop-the-clock awaiting the receipt of the additional information.

## 6. Other scientific topics for discussion

### Scientific Committee draft guidance on nanomaterials

The "draft EFSA Guidance on technical requirements for regulated food and feed product applications to establish the presence of small particles including nanoparticles", for which the [public consultation ended in September](#), was presented and discussed. The guidance follows a mandate from the European Commission (EC) addressing technical requirements for conventional materials (i.e. materials that do not meet the "engineered nanomaterials" definition of the Novel Food Regulation) in order to identify the presence of a fraction of small particles requiring assessment at the nanoscale. The Scientific Committee WG on Nanotechnology is currently addressing the comments received during the public consultation and, simultaneously, updating the SC Guidance on the risk assessment of nanomaterials published in 2018. Specific considerations for FCM are provided in an Annex of the 2018 guidance. EFSA explained the scope of both complementary guidance documents. The draft

“Guidance document on Technical Requirements” is only applicable to conventional materials and provides applicants and other interested parties with the information to be submitted for confirming that the material does not require assessment at the nanoscale. The scope of the SC Guidance on the risk assessment of nanomaterials under update covers both nanomaterials covered by the legal definitions and conventional materials requiring assessment at the nanoscale (i.e. those identified according to the Guidance document on Technical Requirements).

FCM being currently excluded from the scope of the draft guidance on Technical Requirements, questions and options on its applicability to the FCM area were presented and discussed. The WG considered the need for addressing properly the specific considerations required for FCM in both guidance documents. Discussion will continue at the next WG meeting.

### Re-evaluation of phthalates

The WG was informed about the receipt of a new mandate from the EC tasking EFSA with the re-evaluation of phthalates. Once the mandate is formally accepted, it will become publicly available in EFSA’s register of questions. In preparation of this opinion, the EC is requesting the collaboration with ECHA to work together, considering the screening and prioritisation exercise done by ECHA on groups of structurally similar substances that may be relevant as regards their use in FCMs.

## 7. Feedback from EFSA, CEP Panel and the European Commission

In the context of the 16th amendment of Regulation (EC) 10/2011, the EC asked the FCM WG for their considerations on the SML to be set for FCM substance n. 1080 ((triethanolamine-perchlorate, sodium salt) dimer ([opinion](#) adopted by the CEP Panel on 29 April 2020) and the possible implications for adding the substance to two group restrictions (SML(T)). The EC also asked the WG for their views on the possible implications of the classification by REACH of certain cobalt salts as CMRs, as the salts of authorised acids can be used in FCM (in accordance with Article 6(3)(a) of Reg. 10/2011), subject to an SML for cobalt of 50 ppb.

#### 1) FCM substance n. 1080 ((triethanolamine-perchlorate, sodium salt) dimer:

In the context of the 16th amendment of Regulation (EC) 10/2011, FCM substance n. 1080 will need to be added to two group restrictions, for triethanolamine (FCM 793) and perchlorate (FCM 822). In the case of FCM 822, the SML was set to cover the acids and not necessarily the salts. As indicated in the EFSA opinion (2020), the SML for perchlorate is based on the health-based guidance value as set by the CONTAM Panel. The salts will instead dissociate (perchlorate and counter ions in the solution), which makes the salts obsolete in the current listed SML for FCM 822.

#### 2) Cobalt salts:

Salts of authorised acids can be used in FCM on the basis of dissociation (Article 6(3)(a) of Reg. 10/2011). Some cobalt salts have been classified under REACH as CMRs (e.g. cobalt di(acetate) is carcinogenic by inhalation). In view of the REACH classifications, is there a reason to reconsider the SML of 50 ppb for cobalt currently limiting the migration of cobalt from plastic FCM?

For being able to answer this question, the FCM WG indicated that there is a need to first look at the available dataset (mechanisms of action, studies by oral exposure, etc.) to understand whether the carcinogenicity by inhalation also applies to oral exposure, as the REACH classification is based on studies on occupational exposure by inhalation. It was noted that the exposure to cobalt could come from different sources, including FCM, feed additives and contaminants.



## 8. AOB

The WG was informed about new mandates on food contact materials that were received by EFSA since the last WG meeting.

The FCM WG members thanked Anna F. Castoldi, transferring from the FIP unit from October 2020 to another Unit in EFSA, for her support to the work of the FCM WG.

The WG requires additional information to complete the risk assessment. The scientific evaluation is currently suspended, awaiting submission of the additional information requested.

### 5.2. Styrene (FCM 193) (EFSA-Q-2019-00686)<sup>8</sup>

Subsequent to the discussions at the last meetings of the FCM WG and the cross-cutting WG on Genotoxicity, the draft opinion in response to the mandate EFSA received from the EC for re-assessing the safety of styrene for use in food contact materials, was discussed and changes were noted. The revised draft opinion will be scheduled for discussion and possible adoption by the CEP Panel.

### 5.3. 1,4-benzenedicarboxylic acid, 1,4-dibutyl ester (EFSA-Q-2019-00586)<sup>9</sup>

The dossier received from the applicant was discussed. The WG requires additional information to complete the risk assessment. The scientific evaluation is currently suspended, awaiting submission of the additional information requested.

## **6. Feedback from EFSA, CEP Panel and the European Commission**

### **Mandate on high pressure processing**

The mandate from the European Commission was presented (EFSA-Q-2020-00380<sup>11</sup>). It requests a scientific opinion on the efficacy and safety of high-pressure processing (HPP) of food. The first terms of reference cover the efficacy and the potential chemical and microbiological food safety risks in HPP-treated food compared to untreated food or to food submitted to treatments, routinely applied to these foods with the purpose to increase microbiological food safety. HPP is normally applied to pre-packed foods. Three members of the FCM Working Group agreed to join the *ad hoc* BIOHAZ Working Group on HPP of food in order to address the potential risks related to HPP-treated FCM compared to untreated FCM. The scientific opinion will be delivered by the BIOHAZ Panel and specific sections are to be endorsed by the CEP and CONTAM Panels for their respective areas.

## **7. AOB**

The WG was informed about new mandates on food contact materials that were received by EFSA since the last WG meeting.

After the last WG meeting, it was agreed with the Chair to enlarge the WG with an additional expert in the areas of general toxicology, immunotoxicology and nanotechnologies. Moreover, during this meeting it was also suggested to enlarge the WG with an additional expert in the area of chemistry of FCMS.

## 1. Welcome and apologies for absence

The Chair welcomed the participants.

## 2. Adoption of agenda

The agenda was adopted without changes.

## 3. Declarations of Interest of Working Groups members

In accordance with EFSA's Policy on Independence<sup>3</sup> and the Decision of the Executive Director on Competing Interest Management<sup>4</sup>, EFSA screened the Annual Declarations of Interest filled out by the Working Group members invited to the present meeting. ## 4. Agreement of the minutes of the 4<sup>th</sup> WG meeting, held on 12-14 March 2019

The minutes of the 4<sup>th</sup> WG meeting held on 12-14 March 2019 were agreed by written procedure<sup>5</sup>.

## 5. Hearing Expert (s)

Ms Omolola Akintoye, Ms Stefania Bencini and Mr Enrico Galfrè were invited to present their views for item 6.3 of the present meeting. They attended the meeting on 7 May 2019 from 14:00 till 15:15.

In accordance with EFSA's Policy on Independence and the Decision of the Executive Director on Competing Interest Management, EFSA invited Ms Omolola Akintoye, Ms Stefania Bencini and Mr Enrico Galfrè to submit an Annual Declaration of Interest. Their participation in the present meeting was limited to providing testimony, without the possibility to take on any role undertaken by members of the Working Group (i.e. not possible to draft or be involved in the discussion or the adoption of a scientific output), in accordance with the applicable legal framework.

## 6. Scientific topic(s) for discussion

### 6.1. Titanium dioxide treated with fluoride modified alumina (EFSA-Q-2014-00300)<sup>6</sup>

Upon request from the CEP Panel at their last plenary meeting<sup>7</sup>, the cross cutting Working Group on nanotechnologies of the Scientific Committee was consulted for the characterisation of the additive.

The draft opinion was slightly revised following this consultation and the revised draft opinion will be scheduled for discussion and possible adoption by the CEP Panel.

## **6.2. EC mandate: untreated wood flour and fibres (FCM No 96) (EFSA-Q-2019-00089)<sup>8</sup>**

The WG continued the discussion on the mandate received from the European Commission to review whether the authorisation of untreated wood flour and fibres (FCM No 96) is still in accordance with Regulation (EC) No 1935/2004.

## **6.3. Reaction product of stearyl-diethanol-amine with C18 saturated fatty acids (EFSA-Q-2016-00510)<sup>9, 10</sup>**

Upon request from EFSA, the interested parties were given the opportunity to clarify the additional data that the applicant provided following the request of the WG, as the data were not considered satisfactory to conclude on the risk assessment of the substance. Following the discussion during the hearing, EFSA has followed up by providing the interested parties with a written summary of the points discussed and with a letter requesting additional data. The scientific evaluation was suspended, awaiting submission of the additional information requested.

# **7. Other scientific topics for discussion**

## **7.1. FCM evaluation of legislative framework**

The FCM WG continued exchanging views on the evaluation of the legislative framework (Regulation (EU) No 1935/2004) on food contact materials and expressed its views as follows.

The European Commission is currently evaluating the framework Regulation (EC) No 1935/2004 of the European Parliament and of the Council on materials and articles intended to come into contact with food (called hereafter "the Regulation") in relation to its original objectives, the protection of food consumers and the functioning of the market (see [EC website](#)). In this context, the EFSA Food Contact Materials (FCM) Working Group (WG) discussed the functioning of the Regulation using, as a driver, the questionnaire sent to EFSA for its own interview. The FCM WG expresses views notably on the effectiveness of the Regulation in ensuring the safety of consumers, on the effectiveness of the positive list, on the definition of EFSA's role in the risk assessment procedure, on EFSA's tasks and resources, on the differences in the risk assessment for harmonised and non-harmonised material types and on the harmonisation for more material groups.

The FCM WG has the view that the Regulation partly achieves its objectives with regards to addressing human health and the interest of consumers. For regulated FCM types, such as plastics, it achieves the task for regulated intentionally added substances (IAS, i.e. monomers, other starting substances and additives), but does partly for non-regulated substances used and non-intentionally added substances (NIAS). For instance, in the current format of evaluation prior to authorisation, a specific application describing a particular production process and use may become converted to a rather generic listing of the substance open to all and with little or no specifications. In this way, much of the safety assessment (especially for NIAS) can be essentially invisible to users of that

substance. For non-EU regulated FCM types, neither the IAS nor the NIAS are clearly addressed in the Regulation, except under Art. 3, and specific measures foreseen for these FCM types have not been implemented. The Regulation also does not foresee the periodic revision of existing specific measures and provide a mechanism for doing it.

The WG considers the approach of having a list of authorised substances effective in ensuring the safety of the listed chemicals. However according to the current implementation of the Regulation, most authorised substances are listed without specification of the application and conditions of use, which hinders EFSA to apply more appropriate exposure scenarios. The present Union list for plastic encompasses a fraction of the migrating substances. It should be completed with other IAS not authorised/listed yet. In addition, results of the evaluation of NIAS by European and national Authorities should be reported. The safety of other/non-listed migrating chemicals should be addressed. For non-harmonised material types, it is desirable to follow the same approach, however the feasibility under the current system is questionable.

When it comes to considering new scientific knowledge and technological developments, the Regulation is not flexible with existing EU-regulated measures. As mentioned above, no revision and related mechanism is foreseen.

In reviewing the current functioning, other regulatory approaches, such as in the USA, Japan, China and South America (Mercosur) as well as REACH, should be considered to provide a robust and an enlightened evaluation.

The EFSA's role in the risk assessment procedure on regulated substances is defined, but limited to the application described by the petitioner. For instance, the tasks for the evaluation of NIAS and non-regulated IAS (used to manufacture harmonised and non-harmonised FCM types) are not clarified. If the Regulation should make the EFSA responsible for providing guidance for the safety evaluation (not only for applications), it is not the proper place for detailing the methodology. With regards to the evaluation of EU-regulated substances, the Regulation allows re-evaluation and consideration of new knowledge which might affect the safety assessment of authorised substance in relation to human health.

With regards to the applications on regulated substances evaluated by the FCM WG, the dossiers are usually complete, i.e. in accordance with the SCF guidelines and the [EFSA Note for Guidance](#). However, the quality and the amount of details is usually not sufficient to complete and finalise the scientific evaluation without asking for additional data. Requests to applicants for further information are normally met within set time limits.

In the current situation, EFSA would deserve more scientific staff to support the Working Groups and Panel in performing more scientific work. If the revision of the Regulation requires EFSA to do more tasks (such as more applications, more guidance, more coordination), more scientific staffs would be required. As part of new tasks, the WG believes that EFSA could support risk managers in providing guidance on the evaluation of potential risk further to non-compliance and analytical results showing potential concern.

According to the JRC report, there are differences in the restrictions set for non-harmonised and harmonised substances. This does not represent an issue *per se*, since when considering the same substance for different uses or for different material types, there may be important differences in exposure, reactions and fate, etc. However, for non-harmonised FCM types, it is an issue for compliance and mutual recognition when a substance used for the same applications in the same FCM type has different restrictions, such as limits. These problematic differences may originate from



using different testing conditions, different risk management approaches, lack of communication on the substances evaluated at national level and, of much importance, lack of harmonised risk assessment guidance.

The [EFSA FCM Network](#) is a useful platform for exchange of information between Member States, EFSA and other organisations in the area of FCM. The different approaches in the risk assessment, actual cases, new developments in the field and tools are presented and discussed. The Network aims to support and harmonise risk assessment practices in this area. However, as of today, the outcome of the FCM Network activities are more informative than binding. The Network should become a more active driver in regulatory implementation and improvement to increase its impact. It should provide draft guidance to unify risk assessment procedures, notably to facilitate mutual recognition among Member States.

Overall, the FCM WG believes that the Regulation achieves the objectives of food safety and functioning of the market better than a non-harmonised approach. The mixed approach currently operating does not work well, especially for non-EU harmonised FCM types. It notably creates different benchmarks for the safety requirement; a remarkable example is recycled plastics compared to recycled paper and board. More harmonisation is needed and the non-EU harmonised FCM types should be harmonised especially with regards to the safety requirements. The related specific measures should be implemented in priority, because e.g. of exposure to consumers and/or presence of contaminants, and/or NIAS, starting with for paper and board (including their recycling), printing inks, coatings, metals, multi-materials. This may require different approaches than the current one, and not all the assessments may be done by EFSA. However, safety evaluations should be clearly under the control of public institutions/ competent authorities.

Cooperation and coordination between EFSA and ECHA need to be strengthened to avoid duplication, to pool resources and to create synergies. European Reference Laboratory could be mandated to coordinate and harmonise the control of compliance (including document control and checking the safety assessment performed by producers) by National Reference Laboratories, promoting synergies with competence centres rather than duplication.

## **7.2. List of substances identified as emerging risks**

G. Kass from the EFSA SCER Unit presented the procedure they applied for the identification of emerging chemical risks in the food and feed chain. The WG discussed the similarities and differences of this project with the EC mandate on the prioritisation of FCM substances without an SML<sup>11</sup>.

## **8. AOB**

The WG was informed about new mandates on food contact materials that were received by EFSA since the last WG meeting.

The WG discussed the need for strengthening the WG with an additional expert in general toxicology and toxico-kinetics. There is also a need for an expert in toxicity and environmental modelling, computer chemistry and QSAR.

### **Interests and actions resulting from the screening of Annual Declarations of Interest (ADoI)**

This includes e.g. also analytical measurements for industry, in particular in the field of technical innovations for food contact materials (occasionally the test reports are used by the companies in preparation of a dossier to be submitted for evaluation by EFSA), which constitutes a conflict of interest (CoI) with the mandate of the EFSA FCM Working Group. In accordance with EFSA's Policy on Independence<sup>12</sup> and the Decision of the Executive Director on Competing Interest Management<sup>13</sup>, and taking into account the specific matters discussed within the EFSA FCM Working Group, a waiver was granted in accordance with Article 21 of the Decision of the Executive Director on Competing Interest Management. Pursuant to Article 21(6) of the above-mentioned Decision, Dr. Franz's involvement is authorised as "member" in the scientific group for which the waiver is granted, but he is not allowed to be, or act as, a chairman, a vice-chairman or rapporteur of the Working Group.

#### **5.4. EC mandate: untreated wood flour and fibres (FCM No 96) (EFSA-Q-2019-00089)<sup>9</sup>**

EFSA received from the European Commission a mandate to review whether the authorisation of untreated wood flour and fibres (FCM No 96) is still in accordance with Regulation (EC) No 1935/2004. The substance is presently authorised based on its inertness as an additive for the manufacture of plastic food contact materials, and listed in Annex I of Regulation (EU) No 10/2011, with no specific migration limit (SML). The WG started to identify possible criteria, not yet set out in the FCM Note for Guidance, for assessing the safety and support the use of wood and of similar materials from a plant origin, as plastic additives (art. 9 of Regulation (EC) No 1935/2004).

#### **5.5. EC mandate: Prioritisation of substances without a specific migration limit (SML) (EFSA-Q-2019-00150)<sup>10</sup>**

EFSA received from the European Commission a mandate for the priority setting of substances of the FCM Union list which have not been assigned an SML, for future risk assessment purposes. The WG discussed the criteria and tools that may be used in order to place the substances under low, medium and high priority groups.

In accordance with EFSA's Policy on Independence<sup>11</sup> and the Decision of the Executive Director on Competing Interest Management<sup>12</sup>, and taking into account the specific matters discussed within the EFSA FCM Working Group, a waiver was granted in accordance with Article 21 of the Decision of the Executive Director on Competing Interest Management. Pursuant to Article 21(6) of the above-mentioned Decision, Dr. Franz's involvement is authorised as "member" in the scientific group for which the waiver is granted, but he is not allowed to be, or act as, a chairman, a vice-chairman or rapporteur of the Working Group.

In accordance with EFSA's Policy on Independence<sup>13</sup> and the Decision of the Executive Director on Competing Interest Management<sup>14</sup>, and taking into account the specific matters discussed at the meeting in question, the interest above was deemed to represent a Conflict of Interest (CoI) but it has been waived pursuant to the Decision of the Executive Director on Competing Interest Management. This means that the expert should not suffer from the exclusion from the meeting, but he may not be the chairmanship, vice-chairman or rapporteur of the WG.

G. Rivière declared the following interest in relation to agenda item 5.2: his employer ANSES has been involved in the assessment of published literature (between 2017 and 2019) on the toxicology of titanium dioxide as a food additive. In accordance with EFSA's Policy on Independence<sup>13</sup> and the Decision of the Executive Director on Competing Interest Management<sup>14</sup>, and taking into account the specific matters discussed at the meeting in question, the interest above was not deemed to represent a Conflict of Interest for the expert concerned, because this interest is in the context of the experts' employment with a public institution and considered to be of public interest duty and without risk management tasks.
