5.1. Appraisal of oral food challenge studies in the context of allergenicity assessments

The WG discussed the development and adaptation of a risk of bias (RoB) tool for the appraisal of oral food challenges for the diagnosis of food allergy and for deriving minimal eliciting doses for food allergens. The WG discussed the piloting of this tool and the appraisal done by the experts on the three human studies identified in the context of the re-evaluation of behenic acid from mustard seeds (EFSA-Q-2022-00042). The WG reached consensus on the RoB rating.

5.2. Scientific opinion on the re-evaluation of behenic acid from mustard seeds to be used in the manufacturing of certain emulsifiers pursuant to Article 21(2) of Regulation (EU) No 1169/2011 – for permanent exemption from labelling (EFSA-Q-2022-00042)

The WG discussed the information and data submitted by the applicant on 21st November. In particular, the WG discussed the protein and allergen analysis of behenic acid. The data submitted did not fully address the questions previously raised by EFSA. The WG agreed to go back to the applicant for clarifications on data received and to request additional information. The WG will draft a letter outlining the request.

The WG discussed the context of the assessment and the maximum intake of mustard protein that could be expected from emulsifiers manufactured using behenic acid under the conditions of used proposed by the applicant.
