# **5.1.** Presentation and drafting of the Scientific Opinion<sup>3</sup>

The methodologies and approaches used were discussed. The OECD QSAR Toolbox 4.2 was proposed to estimate chemical similarities (LM2-LM6 and terbuthylazine and characterised metabolites MT1, MT13 and MT14) to support read-across.

Where no RV could be derived application of TTC approach was investigated.

According to Commission request, for those metabolites for which RV can be set, EFSA should calculate the consumer exposure – this is not part of PPR Panel mandate and is not further assessed in the Scientific Opinion. Exposure calculations where TTC approach may be used were discussed. Uncertainties in the assessment were identified. Investigation of other potential sources of exposure and literature data were presented.

# 4. Scientific topics for discussion

# 4.1. Presentation and clarification of mandate<sup>3</sup>

The mandate was presented and clarifications were given in accordance to the acceptance letter. The Panel on Plant Protection Products and their Residues were asked to establish health based reference values for the LM metabolites (LM2, LM3, LM4, LM5 and LM6) based on the available evidence, unless the evidence is not considered sufficient to do so. The Panel is also requested to specify any uncertainties associated with the values derived and how such uncertainties could be further addressed in the future.

More specific the Commission asked the Panel on Plant Protection Products and their Residues to:

- Assess the available evidence;
- Consider the data gaps identified in the EFSA Conclusion and whether they could be addressed in light of the current state of the

art on read-across and other alternative in silico and non-testing methods and tools;

- Specify any uncertainties and how these could be further addressed, for example, in case additional safety factors are required;
- Based on these assessments, to establish health based reference values for the LM metabolites (LM2, LM3, LM4, LM5 and LM6) of terbuthylazine.

Furthermore, in case the Panel establishes reference values, EFSA is requested to update the risk assessment for consumers to take into account exposure to the LM metabolites using the reference values established by the Panel in accordance with this mandate. This activity is requested under Article 31 of Regulation (EC) No 178/2002 with a deadline of 3 months from the time the Opinion of the PPR Panel is published in the EFSA Journal. Member States should be provided with an opportunity to submit comments on such an assessment (since it will be an EFSA Output).

It was clarified that though the use of the Guidance on the residue definition is not explicitly said in the mandate, in the acceptance letter it is clearly stated that the mandate is accepted acknowledging that the reassessment will be done following the guidance of the PPR Panel (Guidance on the residue definition), which represents a different methodology than that used in the previous EFSA assessment. The experts agree that the Guidance on the residue definition should be used for the re-assessment.

# 4.2. Structure of the document and sharing of writing tasks

The main chapters of the document were agreed on the basis of the terms of references. Writing tasks were distributed between experts on the basis of their expertise.
