5. Discussion of new contributions

The working group has been informed about the need to define the **SPGs** (Specific Protection Goals) in detail and to develop different options for risk managers to choose.

New simulations of the beetle population model have been presented and discussed. It was concluded that it was demonstrated that in-field impacts can produce off-field effects and that wide field margins and a diverse landscape can buffer in-field effects.

Alignment with the ongoing working group of the scientific committee on recovery is important as well as harmonization of the terminology used.

New contributions on the ecosystem service pest control and on food web support were discussed and agreed. Once more it was pointed out that it is difficult to make a quantitative link between population level effects and effects on ecosystem service because of a lack of data.

The definition of a reference tier was discussed. Possible reference tier options are field studies or models which include data from field studies.

An update of the exposure chapter was presented and the group agreed on a way forward to calculate exposure in the off-field.
