Flowchart

The WG drafted a flowchart synthesizing the approach, using the model proposed for the insecticides which can be kept with a few adjustments. This flowchart consists of 5 main questions to be answered by the applicants.

Excel spreadsheet

Excel file DATA FORM for data collection (fungicides and non-fungicides alternatives), was adapted from the previous insecticides version. Some elements were added or modified and the non-fungicides methods list was renewed. Also, the MOA classification considered is according to the FRAC code list 1 (fungicides sorted by code, intended as target site of action). No need to radically change the structure

Differences between fungicides and insecticides approach for this spreadsheet were highlighted by John Lucas. Concerning the non-fungicide methods there are differences between fungicides and insecticides BCAs. The WG heavily revised them adding a few more while changing some main group categories.
